The Environmental Clearance was issued vide Lr. No. SEIAA/TN/EC/1(d)/013/ F.No.282/2010 dated 10.11.2010 to M/s.RMZ Infinity (Chennai) Limited for the Proposed Expansion of IT Park SF. No. 25/4A2, 25/4D2, 25/4E2, 25/4G2, 25/4H1, 25/4H2, 25/4H3B, 25/4H4, 25/4H6A, 26, 27, 28/2, Porur Village, Madhuravoyal Taluk, Thiruvallur District, Tamil Nadu State under Category "B1" of Item 8(b) "Area & Township Development Projects" under the EIA Notification, 2006 as amended.

Now, the proponent has submitted an application vide Online proposal No. **No: SIA/TN/INFRA2/543847/2025, 05/07/2025** seeking **Name Transfer of the Environmental Clearance** dated: 30.05.2017.

Discussion of SEIAA:

The proposal was placed in 854th Authority meeting held on.17.07.2025. The Authority noted the following:

- i) Environmental Clearance was issued to the M/s.RMZ Infinity (Chennai) Limited for the Expansion of IT Park SF. No. 25/4A2, 25/4D2, 25/4E2, 25/4G2, 25/4H1, 25/4H2, 25/4H3B, 25/4H4, 25/4H6A, 26, 27, 28/2, Porur Village, Madhuravoyal Taluk, Thiruvallur District, Tamil Nadu – under Category "B1" and Schedule S.No.8(b) "Township and area development Projects" vide Lr. No. SEIAA/TN/F.4701/EC/8(b)/520/2016 dated 30.05.2017. Subsequently, Amendment of Environmental Clearance vide Letter No. SEIAA-TN/F. 4701/EC/A/8(b)/ 520/2016, dated: 23.10.2019.
- ii) Now, the PP has submitted an application in Form-7 vide Online No: SIA/TN/INFRA2/543847/2025, 05/07/2025 requesting transfer of EC issued in the name from *M/s. RMZ Infinity (Chennai) Private Limited* to *M/s. Chennai Business Tower Private Limited*.
